



## 24.0186 acres

Situate in Section 17, Town 2, Range 5 M.Rs, Miami Township, Montgomery County, Ohio. Being part of a 41.9279 acre (by deed) parcel conveyed to Encrete Investments Co. Inc., by Deed Book 2022, Page 190 (1/2% interest), Velma I. Joslin, FKA Velma I. Munchel by CF/T-15-051951 (1/16th interest), Judy M. Wenzler by D.M.F.91-022A09 (1/16th interest), Nancy E. Meeker (1/24th interest), by I.R. Deed-16-013183, Steven R. Trimborn, Trustee by CF/T-059153 (1/4th interest) of the Deed Records of Montgomery County, Ohio, and being a tract of land more particularly described as follows:
